Additional Fees

Registration Fee:	\$32 per student per year (*Waived if you sign up for autopay by September 30th)
Recital Video Fee:	\$10 per family per year
Costume Fee:	\$80 per dance per year
Recital Tickets:	\$18 per ticket with Credit Card, \$17 per ticket with Check, \$16 per ticket with cash
Drop-in rate:	\$22 per class
Private Lesson:	\$38 per half hour
Late Fee:	\$25 per month for payments made more than 7 days after the first class of the month

Explanations

1. Tuition rates listed are charged on the first business day of every month that your dancer is enrolled.

2. The registration fee is a one time annual fee paid at the time of registration. This fee is waived if you sign up for automatic payments at the time of registration within the month of September but will be reapplied if you withdraw from automatic payments at any time within the dance year.
3. Our prices have been updated in order to comply with new credit card regulations and now include all credit card and ACH processing fees. Prior to 2026 these fees were charged on top of our listed prices but they are now included in the prices listed. In addition, there will now be a 5% cash discount offered for tuition payments made in cash.
4. The costume fee is for your child's costume that they will wear for the recital and that you get to keep. If you choose not to participate in the recital you do not have to pay this fee. If you do not want to participate in the recital you must email Liz before November 1st in order to avoid costume fees automatically applied to your account.
5. Costume fees are due in full by February 1. You may pay the total of your costume fees in full at any time before February 1 (email Liz if you prefer this option). Otherwise, your costume fees will automatically be divided fees into 4 payments of \$20 and added to your tuition for the months of November – February.
6. The recital video fee is \$10 and covers the cost of a professionally recorded recital video that is emailed to all participants after the recital. The fee is applied with tuition on March 1.
7. Recital tickets go on sale starting in April. Prices listed are per seat. Dancers performing in the show do not need a ticket to the show.
8. A 6% state sales tax and 1% LOST is applicable to all tuition payments.
9. A late fee of \$25 will be applied to payments more than one week late.
10. The family rate applies only to siblings with a total of 11 or more weekly classes between them. For example if Sibling A has 5 classes and Sibling B has 7 classes you would pay \$174 /month for Sibling A's 5 classes, \$189 /month for sibling B's first 6 classes and an additional \$13 /month for Sibling B's seventh class for a total of \$376 /month before tax.
11. All Protégé Company prices are in addition to your monthly tuition and do not count towards the total weekly hours of class.
