

## **2025-26 Fees & Tuition Rates**

### Processing Fees & Explanations

1. The registration fee is a one time annual fee paid at the time of registration. This fee is waived if you sign up for automatic payments at the time of registration within the months of September and October but will be reapplied if you withdraw from automatic payments at any time within the dance year.

2. The costume fee is for your child's costume that they will wear for the recital and that you get to keep. If you choose not to participate in the recital you do not have to pay this fee. If you do not want to participate in the recital you must email Liz before November 1<sup>st</sup> to avoid costume fees automatically applied to your account.
3. Costume Fees are due in full by February 1. You may pay the total of your costume fees in full at any time before February 1 (email Liz if you prefer this option). Otherwise, your costume fees will automatically be divided fees into 4 payments of \$20 and added to your tuition for the months of November – February.
4. The recital video fee is \$10 and covers the cost of a professionally recorded recital video that is emailed to all participants after the recital. The fee is applied with tuition on March 1. It does not include recital tickets, which are purchased for \$15 (plus taxes & fees) per ticket starting in April.
5. A 6% state sales tax is applicable to all tuition payments and costume fees.
6. A processing fee of 1% + \$0.20 is applied to all ACH (direct debit from your checking account) transactions.
7. A processing fee of 3.05% + \$0.35 is applied to all credit card transactions.
8. A late fee of \$25 will be applied to payments more than one week late.
9. The family rate applies only to siblings with a total of 11 or more weekly classes between them. For example if sibling A has 5

hours of class and sibling B has 7 hours of class you would pay \$159 /month for sibling A's 5 hours, \$174 /month for sibling B's first 6 hours and an additional \$10 /month for sibling B's seventh hour of class for a total of \$343 /month before tax.

10. All Protégé Company prices are in addition to your monthly tuition and do not count towards the total weekly hours of class.
